## ERICDOA LIFELINE GAME OFFICIAL TERMS AND CONDITIONS

## NO PURCHASE NECESSARY.

The ericdoa Lifeline Game ("Contest") begins at 12:00:00 AM Pacific Time ("PT") on April 8, 2022 and ends at 11:59:59 PM PT on April 16, 2022 ("Contest Play Period"). The Sponsor's agent's computer server will be the time keeping device for the purposes of this Contest.

Players have three (3) lives to use to collect as many points as possible. Upon completion of a specific Task, the corresponding Player will be awarded point(s) and he, she or they must follow on-screen instructions to submit scored points in order to track points via the Contest leaderboard. You may also enter by connecting with ericdoa via Apple music service ("Service Provider 2"), register a nickname (of your choice), email address, country and click "Enter Game". Using the cursor or the spacebar on your computer or the touch screen on your mobile device or computer, collect points by jumping over the obstacles (each a "Task"). Players have three (3) lives to use to collect as many points as possible. Upon completion of a specific Task, the corresponding Player will be awarded point(s) and he, she or they must follow on-screen instructions to submit scored points in order to track points via the Contest leaderboard. Alternatively, you may also enter by clicking "Skip" and "Start Game". Using the cursor or the spacebar on your computer or the touch screen on your mobile device or computer, collect points by jumping over the obstacles (each a "Task"). Players have three (3) lives to use to collect as many points as possible. Upon completion of a specific Task, the corresponding Player will be awarded point(s) and he, she or they must follow on-screen instructions to submit scored points in order to track points via the Contest leaderboard. Points will be displayed on the leaderboard per Player based upon the points accumulated for completed Tasks per play. Tasks are subject to change at Sponsor's sole discretion. Points are subject to all notices posted online including Sponsor's privacy policy. Multiple Players are not permitted to share the same nickname and/or email address. **WINNER DETERMINATION:** At the conclusion of the Contest, the ten (10) top scoring Players with the greatest number of points displayed on the leaderboard will be declared the winners. In the event of a tie among Players, the Player among the tied Players, who accumulated the most points in overall play will be deemed a winner.
